Information Kerala Mission – Establishment – Fixation of pay in respect of staff of IKM-orders issued

ORDER

As per G.O read as 1st paper above Government had decided to restructure IKM and as per reference 2nd & 3rd cited Government constituted two Committees to look into the aspects of resource mobilization and for formulating a road map for completing the ongoing activities of IKM and also for changing the mission mode project and bringing it under the control of Local Self Government Department.

As per G.O read as 4th paper Government had approved the revision of remuneration of technical staff of IKM. In the G.O, it was also ordered that the revision in remuneration for employees in corporate Management/Administration at Head Office shall be taken up separately only after the restructuring of the Head Office. It was also ordered that the preferential remuneration for software personnel shall be decided after formulating road map and the need assessed.

As per G.O read as 5th paper above Government have approved the road map for completing the ongoing activities of Information Kerala Mission.

As per G.O read as 6th paper above Government have accorded sanction for the pay revision of non-technical personnel including Corporate Management/ Administration and to the preferential pay for Software Development Personnel subject to the following conditions.

1. The five erstwhile Managers would continue as Programme Co-ordinators for six months in view of the need for monitoring Plan formulation and implementation of Local governments. Their continuance beyond six months would be decided only with approval of Finance Department.

2. The services of the present Group Director would be terminated forthwith and a new person would be selected on deputation basis. Till then an Officer not below the rank of Joint Director of Panchayaths would be put in full additional charge.
3. In accordance with G.O(MS) 128/07/LSGD dated 14.05.2007, officers of IKM would continue to assist the State Resource Group on working arrangements as of now.
4. Software personnel is defined as "a technically qualified person (having qualifications specified in the report prepared by CMD on Information Kerala Mission in April 2008) engaged in analysis, development including coding, testing, verifying and validating software and other computer related programmes including modifications". This definition has the approval of Information Technology Department.

In the above circumstances the monthly remuneration of Staff of IKM are to be revised w.e.f 01.11.2007. The fixation statement in respect of each employee with effect from 01.11.2007 will be issued separately.

All employees are directed to submit option in the prescribed form appended on or before 19.09.2009. Option once exercised shall be final and no re-option shall be allowed. If no option is exercised, within the prescribed date it shall be deemed that they have no option and their pay will be revised with effect from 01.11.2007.

Accounts Officer is authorised to draw the remuneration as per the fixation statement prepared based on the option if any and arrange disbursement accordingly subject to deductions if any.
